PRE-REGISTRATION	From 12 July 2023 to 3 November 2023	The deadline for candidates to complete the access minimum documentation will be 13 November 2023. The month of August shall not be counted for academic purposes and no new pre-registrations will be able to be done. Candidates pre-registered in July will have access to the document manager to upload documentation, which will be checked from September.			
ADMISSION	From 13 July 2023 to 4 December 2023	Periodically, the Coordination will admit on academic grounds candidates depending on the number of candidates pre-registered who have submitted the minimum documentation. Admission on academic grounds means that the candidate has a place during the same academic year of the pre-registration. The month of August shall not be counted for academic purposes. Admissions done during August will be processed from September.			
REGISTRATION	From 1 October 2023 to 19 December 2023	Candidates admitted in this phase who have not registered within this period may still do it beyond the deadline but they will be required to pay the corresponding additional fees. The final deadline to register for candidates pre-registered in this phase is 22 March 2024.

ADMISSION	From 12 January 2024 to 18 March 2024	Periodically, the Coordination will admit on academic grounds candidates depending on the number of candidates pre-registered who have submitted the minimum documentation. Admission on academic grounds means that the candidate has a place during the same academic year of the pre-registration.			
REGISTRATION	From 15 January 2024 to 22 March 2024	Candidates admitted in this phase who have not registered within this period may still do it beyond the deadline but they will be required to pay the corresponding additional fees. The final deadline to register for candidates pre-registered in this phase is 14 June 2024. If registration is done from 30 April 2024, the student will only be able to attend the 2nd call (June).
