1 st PRE-REGISTRATION PHASE				
PROCESS	PERIOD	OBSERVATIONS		
PRE-REGISTRATION	From 14 July to 27 October 2025	The deadline to complete the minimum documentation of access and admission will be 10 days from pre-registration or until 27 October 2025. The month of August shall not be considered for academic purposes and no new pre-registrations will be able to be done. Candidates pre-registered in July will have access to the document manager to upload documentation, which will be checked from September.		
ADMISSION	From 14 July to 4 December 2025	Periodically, the coordination will admit on academic grounds candidates depending on the number of people pre-registered who have submitted the minimum documentation. Admission on academic grounds involves reservation of the place for the same academic year in which pre-registration has been done. The month of August shall not be considered for academic purposes and admissions done in August will be managed from September.		
REGISTRATION	From 1 October to 18 December 2025	Candidates admitted in this phase who have not registered within this period may still do it beyond the deadline paying the corresponding fees. The final deadline to register for candidates pre-registered in this phase is 26 March 2026. In case of conditional registration, the deadline to submit the pending documentation is 30 April 2026.

PRE-REGISTRATION	From 12 January to 23 February 2026	The deadline to complete the minimum documentation of access and admission will be 10 days from pre-registration or until 23 February 2026.		
ADMISSION	From 12 January to 18 March 2026	Periodically, the coordination will admit on academic grounds candidates depending on the number of people pre-registered who have submitted the minimum documentation. Admission on academic grounds involves reservation of the place for the same academic year in which pre-registration has been done.		
REGISTRATION	From 13 January to 26 March 2026	Candidates admitted in this phase who have not registered within this period may still do it beyond the deadline paying the corresponding fees. The final deadline to register for candidates pre-registered in this phase is 12 June 2026. If registration is done after 30 April 2026, the student will only be able to attend the 2 nd evaluation call (June). In case of conditional registration, the deadline to submit the pending documentation is 30 April 2026.

EXTRAORDINARY PHASE OF PRE-REGISTRATION

- The programme coordinator may request to open a 3rd phase if there are candidates who may have all the necessary documentation that meets all the requirements for registration before the registration deadline.
- Only candidates who have been awarded a scholarship, contract or doctoral grant which establishes that they must register to the 2025-2026 academic year can participate in this phase.
- For candidates pre-registered during this 3rd phase the deadline to register to the programme for the academic year 2025-2026 will be 12 June 2026.
